C) JUSTIFICATION	C) JUSTIFICATION
Les biens culturels proposés peuvent être considérés comme étant d'une valeur universelle exceptionnelle parce qu'ils remontent à une haute antiquité et qu'ils sont directement et étroitement liés au culte et à la légende d'Aphrodite (Vénus), qui, par le rayonnement de la poésie Homérique est devenue l'idéal de la beauté et de l'amour, inspirant écrivains, poètes et artistes à travers l'histoire humaine. Les biens culturels proposés répondent aux critères d'inclusion 3 et 6. Depuis les temps Néolithiques (6e millénaire av. J.C.), Chypre a été un lieu de culte à des divinités pré-helléniques de la fertilité; un grand nombre des vestiges archéologiques proposés remontent à une haute antiquité; le temple d'Aphrodite lui-même date du 12e siècle av. J.C., et témoigne d'un des plus anciens établissements Mycéniens. D) INTEGRITY, AUTHENTICITY AND
STATE OF PRESERVATION

En octobre 1979, lors du Bureau de la Convention du patrimoine mondial, l'ICOMOS avait souligné dans son rapport, que les sites de Petra tou Romiou et de Nea Paphos étaient menacés par des développements commerciaux (touristiques) et qu'ils demandaient une attention particulière, les membres du Bureau de la C.P.M. parlant d'effet de banalisation possible.

Le Secrétariat de l'UNESCO ayant reçu des garanties du gouvernement de la République de Chypre à l'effet qu'aucun développement touristique ne sera permis dans les environs des Sites 1,2 et 3 et que ce dernier acquiert de façon systématique toutes les propriétés situées à l'intérieur de ces zones, l'ICOMOS considère que ces garanties sont suffisantes pour permettre l'inscription du bien proposé.

Le temple principal d'Aphrodite à Kouklia requiert des travaux urgents de préservation. La majorité du site de la ville n'a pas encore été fouillé mais représente un grand potentiel pour l'avenir.

Plusieurs équipes archéologiques internationales assurent la qualité des recherches qui sont effectuées à Paphos.

In October 1979, during the Bureau of the World Heritage Convention Committee, ICOMOS had underlined in its report that the sites at Petra tou Romiou and Nea Paphos required special attention as they were threatened by commercial (tourist) developments, the members of the Bureau of the W.H.C. cautioning on the possible effect of triteness.

The UNESCO Secretariat has received guarantees from the Republic of Cyprus government to the effect that no touristic developments will be tolerated in the neighbourhood of Sites 1, 2 and 3 and that they were systematically acquiring all properties located inside these areas. ICOMOS believes that these guarantees are sufficient to permit inscription of the nominated properties.

Aphrodite's main temple in Kouklia requires urgent preservation measures. The townsite itself is mainly unexcavated but offers a great potential for future discoveries.

Several international archaeological teams guarantee the quality of research at Paphos.

F) JUSTIFICATION:

1- According to the general principles of the Convention:

Because of their great antiquity, and because they are closely and directly related to the cult and legend of Aphrodite (Venus), who under the influence of the Homeric poetry became the "ideal of beauty and love, inspiring writers, poets and artists throughout human history", the nominated properties can indeed be considered to be of outstanding universal value. The nominated properties meet the evaluation criteria n° iii and vi.

2- According to the criteria for inclusion:

iii- Be unique, extremely rare, or of great antiquity.

Prehellenic fertility deities were worshipped in Cyprus since Neolithic times (6th millenium B.C.); many of the archaeological remains are of great antiquity; the temple of Aphrodite dates back to the 12th century B.C. and represents one of the earliest Mycenaean settlements; the mosaics of Nea Paphos are extremely rare and rank amongst the best examples in the world; these mosaics range from Hellenistic down to Byzantine times. The architectural remains of villas, palaces, theaters, fortress, rockhewn peristyle tombs are of outstanding historical value as they are one of the keys of our understanding of ancient architecture.

vi- Be most importantly associated with ideas or beliefs, with events or with persons of outstanding historical importance or significance.

The universal religious and cultural importance of the Cult of Venus, local fertility deity of Old Paphos which developped into the world

goddess of love and beauty, is an indubitable fact that contributes to the outstanding value of these properties.

G) INTEGRITY, AUTHENTICITY AND STATE OF PRESERVATION.

Most of the archaeological remains of the nominated properties are in good condition.

In spite of the existing legislation for the protection of Ancient Monuments, the sites at Petra tou Romiou and Nea Paphos require special attention as they are presently threatened by commercial (touristic) development.

Aphrodite's main temple in Kouklia requires urgent preservation measures. The townsite itself is mainly unexcavated but offers a great potential for future discoveries.

Most of Nea Paphos, the capital of Cyprus for more than six centuries, remains also to be excavated.

Several international archaeology teams assure the quality of research done at Paphos.
